Christina Hart, Town Clerk, stated that in accordance with Colorado State Statute, notice of the public hearing was properly posted and published in the Eastern Colorado News on July 8, 2022. Legal #2670.

Steve Hebert, Planning Manager, reported to the Trustees the applicant is proposing a 9,544 square-foot building with a showroom, office, restrooms, employee break room and a six-bay service area for servicing vehicles and storing tires. The facility would include 34 parking spaces. The location of the proposed final development plan is 1036 South First Street.

Christina Hart, Town Clerk, stated that in accordance with Colorado State Statute, notice of the public hearing was properly posted and published in the Eastern Colorado News on July 1, 2022. Legal #2666.

Steve Hebert, Planning Manager, reported to the Trustees the applicant is proposing subdividing 104.27 acres into two lots. Lot 1 is 15 acres and Lot 2 is the remaining 89.27 acres. The property is located at the northeast corner of Kiowa-Bennett Road and I-70. The applicant has also submitted an application Case No. 22.13, to rezone the 15-acres Lot 1 to I-Industrial District. The proposed near-term use of Lot 1 is an outdoor recreation vehicle (RV) storage lot. A future conditional use permit (CUP), reviewed by the Planning and Zoning Commission and Board of Trustees, and site plan review by the Zoning Administrator, will be required for the RV facility.
