1. Artwork Dedication - Boys Scouts

2. Amendment 74 Resolution To Oppose

Trish Stiles, Town Administrator, reported an abundance of emails from CML to the Town of Bennett and other Colorado Municipalities expressing their concern and opposition of proposed Amendment 74, a 2018 election ballot issue. The proposed amendment could potentially limit the capacity of municipal government, without subjecting the municipality to additional lawsuits.

CML has recommended, the municipalities potentially impacted, to produce a resolution to oppose Amendment 74. CML provided a draft resolution which many municipalities have adopted. Staff is recommending approval of Resolution 730-18 to protect the Town of Bennett from possible litigation.

Melinda Culley, Light & Kelly P.C., the Board of Trustees by the "Fair Campaign Practices Act", is allowed to adopt a resolution to support an opposition of a ballot issue.
