## 5. PUBLIC HEARING

# A. Case No. 19.16FDP - Intermountain Rural Electric Association Final Development Plan

Mayor Royce Pindell opened Case No. 19.16FDP, a public hearing to consider a Final Development Plan for Intermountain Rural Electric Association ("IREA") Bennett District Operations Facility. The public hearing was opened at 7:05 p.m.

Lynette White, Town Clerk, stated that in accordance with State statute, notice of the public hearing was properly posted and published in the Eastern Colorado News, November 1, 2019 as Legal No. 2285.

There were no disclosures presented by the Board of Trustees.

Steve Hebert, Town Planner, introduced the applicant, Doug Hahn, Owners Representative and presented the application, to consider a final development plan for a development of IREA's Regional Operations and Maintenance Facility on a 14 acre site at Bennett Crossing. The site will be located at 1092 Cedar Street at the northeast corner of Marketplace Drive and Cedar Street. The proposed facility will include administrative offices, a training room, maintenance shop, warehouse, vehicle storage and wash bay, covered storage, and an outdoor storage yard.

Staff finds the proposed FDP:

- 1. is consistent with the Town of Bennett Comprehensive Plan;
- 2. is in compliance with the provisions of Chapter 16 Land Use and Development, of the Bennett Municipal Code;
- 3. is consistent with the Bennett Crossing Outline Development Plan; and,
- 4. conforms to the Town of Bennett Development Design Guidelines.

Staff recommends the Board of Trustees approve the IREA Final Development Plan, subject to the following conditions:

- 1. Fire Department approval is required for all FDC, fire hydrant locations and fire apparatus setbacks.
- Prior to final approval of the FDP and prior to the issuance of the first building permit for the property, the applicant shall execute a water service agreement.
- 3. Make other minor modifications as directed by Town Staff, Attorney, and Engineer.

Additional discussion by the Board of Trustees included landscaping, walkability, hazardous waste mitigation, and fencing.

Doug Hahn, LKA Partners and Evan Roberts, IREA, responded to questions presented by the Board of Trustees.
