Ms. Price advised that while the firms of Emerald Isle, Metco, and Brightview Landscape Services expressed interest, the firm of Brightview Landscape Services provided the only bid.

Ms. Price is recommending Brightview Landscape Services for Phase 2 of the Town Hall Landscaping, not only due to their history with the Town of Bennett, their bid submittal of \$73,773.08 is well under the \$129,300 proposed budget.
