Clarification: Project striping shall be thermoplastic.

<u>Clarification</u>: Pearl Street is used for emergency vehicle access and residential access for two residential homes to the east, and therefore cannot be subject to full closure from the Cedar Street intersection east. Full closures will be allowed from SH 79/First Street east to the Cedar Street intersection, west side (Cedar-Pearl intersection cannot be fully closed).

A single lane access through the Cedar Street intersection and east through the construction area, will be acceptable, including overnight, with appropriate signage and cone/barrel traffic control, with flashers required for overnight lane/shoulder closures. The traffic volume is low through the Cedar Street intersection and east of the intersection, and sole-duty assigned flaggers will not be required. As with all civil construction, incidental inquiries by Pearl Street users to the construction crew should be anticipated. On-site notification signage with date information, contact info and phone number should minimize these.

<u>Clarification:</u> Material testing will be provided by the Project Owner, the Town of Bennett.
