# **STAFF REPORT**



#### **Management Summary**

#### <u>CodeRED</u>

In July 2021, the Town of Bennett successfully implemented CodeRED, a high-speed emergency notification service. Since implementation and in combination with CodeRED's database, 1,359 Bennett residents have registered to receive either emergency alerts or emergency and general alerts from the Town of Bennett.

#### 2021 Town Events

#### • Community Clean Up Day

Community Clean Up Day was held on June 20, 2021, at the Alpine East Regional Landfill in partnership with Green for Life and CORE (formerly IREA). Town Staff will be exploring options for a spring and fall Clean Up Day in 2022.

#### • State of the Town

The Town was proud to host the State of the Town in person again on July 23, 2021. This year was very successful with over 85 RSVPs and 11 table sponsors.

#### • Bennett Days

The Town hosted the 11<sup>th</sup> annual Bennett Days this year and was able to return to a more traditional event. Highlights from this year's Bennett Days include a parade, vendor market, family fun zone, Town and Board booths, giveaways, beer garden, stick horse rodeo, Bennett Days Art Show, bull riding and fireworks.

Staff received positive feedback from residents and community partners about the event who were grateful for the opportunity to celebrate.

#### • Bennett Arts Council Events

- The Bennett Arts Council hosted several virtual classes in partnership with Anythink Libraries in March, April and May.
- On April 30, the Arts Council worked with musician, John King, for a virtual concert, which reached over 650 people on Facebook.

- Party in the Park was held in June, July and August with an average of 60 residents attending each event.
- On August 28, 2021, the I-70 Corridor Art Show and Artisan Market was held at Morgan Community College. There were 25 vendors/artists and over 100 attendees for this event.
- The Bennett Days Art Show was held at Bennett Days on September 11 and featured the art of 11 local artists.

# **Communications and Strategic Plan Goals Update**

#### Increase visitors to the Town Website by 10% annually.

• From Feb 23, 2021 – September 21, 2021 there have been approximately 86,675 page views recorded through Google Analytics. This puts us on track to surpass the 10% increase annually.

#### Increase Facebook followers by 8% annually.

- The Town of Bennett currently has 2,829 followers.
  - This is currently a 13.3% increase from 2020
- Facebook Likes: 2,610 total; 8.1% annual increase from 2020
- Twitter Followers: 313 total; 4.7% annual increase from 2020
- Instagram Followers: 228 total; 26.6% increase from February 2021

#### Increase the number of subscriptions to the Town's eNewsletter by 7% annually.

- Town Staff has already surpassed this goal for both the Bennett Broadcast and Board Update Newsletter
  - Bennett Broadcast 23.2% increase since December 2020
  - Board Update 24.4% increase since December 2020

#### Ensure responses through social media and the website are answered within two business days.

- The current staff response rate on Facebook is within a day of receiving the message.
- The Town has had a fillable form on the "Contact Us" page where residents can submit questions and inquiries. All of those inquiries are answered within one business day of receiving the request.

#### Increase attendance for all Town run events meetings and programming by 5% annually.

• Town Staff has increased attendance to Town events by more than 5% in 2021 due to the reduced capacity in 2020. Going forward, attendance for 2021 events will be a more accurate baseline to track attendance increase for events.

#### Increase use of press releases and media advisories sent to local news outlets by 10% annually.

• So far in 2021, Town Staff has sent 22 press releases to local media as well as posted on the website. This is currently on tract to surpass the 10% increase.

SUBJECT: Town Attorney's Office Progress Report

### Management Summary

The following are a few of the projects we have been working on and monitoring for Bennett:

- **Fishing pond parcel:** We have been working with Taeler Houlberg, Dan Giroux and the Antelope Hills developer to finalize the acquisition of property and an easement for a Town-owned fishing pond/stormwater detention pond at Antelope Hills.
- Election complaints: The Town's regular municipal election is scheduled for April 2022. In advance of that election, we will be working with Christina Hart on proposed amendments to the Town Code to address recent changes to the Fair Campaign Practices Act (FCPA). Historically, FCPA complaints have been filed with and resolved by the Secretary of State. This changed with the enactment of C.R.S. § 1-45-117.5(9), which provides: "Any complaint arising out of a municipal campaign finance matter must be exclusively filed with the clerk of the municipality." As such, we will be working with staff on rules and procedures for accepting and processing FCPA complaints related to Town elections.
- Festival permits: The Colorado General Assembly recently enacted SB 21-082 authorizing certain liquor licensees, including breweries, bars and restaurants, to apply for festival permits allowing them to hold up to nine festivals in a twelve-month period. SB 21-082 allows the Town to create a local permit system for festivals. If the Town decides not to implement a permit system, the licensee need only obtain a state permit to hold the festival. We will be working with Christina Hart on possible amendments to the Town Code to address local festival permits.
- Chapter 16 amendments: We are working with Steve Hebert and Taeler Houlberg on updates to Chapter 16 of the Town Code regarding land use and development. This includes updates to make the Code consistent with current State law, including HB21-1222 which requires local governments to treat family child care homes as residential property for purposes of zoning, land use, fire and life safety, sanitation, and building code regulations.
- **Recent legislation:** We have been monitoring recent legislation that may impact the Town, including:
  - **HB21-1314:** Effective January 1, 2022, the state can no longer suspend an individual's driver's license due to unpaid traffic tickets.
  - **HB21-1071:** Effective January 1, 2026, the Town is allowed to conduct its municipal elections using instant runoff/ranked choice voting as part of a coordinated election with a county.

- **SB21-250:** Updates the municipal recall statutes to allow an appointed local government official to be recalled from office.
- **HB21-1108:** Updates anti-discrimination laws to protect gender identity and gender expression in employment, housing, access to and participation in public services, education, youth services, criminal justice, and transportation.
- **SB21-077 and SB21-199:** Repeals the requirement that local governments require verification of lawful presence in the United States for licensing and public benefits.
- **HB21-1025:** Amends the Open Meetings Law (OML) to clarify that e-mail communication between elected officials related to scheduling and availability, forwarding of information, responding to an inquiry from a constituent, or posing a question for later discussion do not constitute a meeting for OML purposes.
- **HB21-1110:** Requires municipalities to develop an accessibility plan to ensure people with disabilities have access to local websites.

Since our last report, we have worked with staff and consultants to complete the following projects:

- Amendments to Chapters 1 and 2 of the Bennett Municipal Code
- Easements for Bennett Ranch development
- Bennett Village Subdivision Agreement
- Development agreements for QuikTrip, Shops at Bennett
- Construction contract for public works building
- Construction manager at risk contract for Well Site 6
- Groundwater withdrawal and management agreement
- IGAs for animal control services, access control plan
- Bennett Days agreements
- Various land development projects

#### Board Action

As noted above, we will likely bring proposed amendments to the Town's election, liquor and land use ordinances to the Town Board in the upcoming months.
