A RESOLUTION SUPPORTING THE GRANT APPLICATIONS FOR OPEN SPACE GRANTS FROM ARAPAHOE COUNTY OPEN SPACE FOR FUTURE PARK PHASE III DESIGN AND ARAPAHOE COUNTY PARK AND OPEN SPACE VIDEO SURVEILLANCE

WHEREAS, the Town of Bennett has set priorities in its 2019 Parks, Trails and Open Space Master Plan to develop new facilities which are complementary to the Town's existing parks, trails and open space system and to improve access to recreational facilities through the development of pedestrian pathways and trails; and

WHEREAS, the Town of Bennett hopes that the Phase III Design of Future Park in the Antelope Hills subdivision will enhance the existing park which is open to the public; and

WHEREAS, the Town of Bennett is requesting \$45,000 from Arapahoe County Open Space for the Future Park Phase III Design Project; and

WHEREAS, the Town of Bennett hopes that the installation of park surveillance at the following Arapahoe County Amenities which are open to the public including, Future Park, the Bennett Regional Park and Open Space pavilion, Bennett Regional Park and Open Space fishing pond, and Bennett Regional Park and Open Space bathrooms will deter further vandalism in the open space and park; and

WHEREAS, the Town of Bennett is requesting \$90,000 from Arapahoe County Open Space for the Arapahoe County Park and Open Space Video Surveillance Project.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF TRUSTEES OF THE TOWN OF BENNETT, COLORADO:

<u>Section 1</u>: The Board of Trustees of the Town of Bennett strongly supports the applications to Arapahoe County Open Space for the Phase III Future Park Design Project and the Arapahoe County Park and Open Space Video Surveillance Project.

<u>Section 2</u>: The Board of Trustees of the Town of Bennett acknowledges that the grant applications include matching funds in the amount of \$5,000 and \$10,000 which the Board of Trustees is solely responsible to provide if a grant is awarded.

Section 3: The Board of Trustees of the Town of Bennett has secured the matching funds in the amount of \$5,000 and \$10,000 and authorizes the expenditure of funds necessary to meet the terms and obligations of any Grant awarded.

Section 4: This resolution to be in full force and effect from and after its passage and approval.

SUBJECT: Section 16.2.470 – Land Uses (Permitted Use in a Public Zone District – Cemetery)

Background

Cemetery is defined in Section 16.2.210 of the Bennett Municipal Code (BMC) as, "land used or intended to be used for the burial of the dead and dedicated for cemetery purposes. A cemetery may include a funeral home or mortuary or a columbarium, but shall not include a crematory." No cemeteries are currently located within the Bennett town limits. The BMC currently permits cemeteries as a conditional use in the A (Agricultural), R-1 (Low Density Residential), and R-1A (Alternate Low Density Residential) zones.

This is a proposed change to the code which would allow a cemetery as a permitted use in the Public Zone. A request to annex the Town's cemetery will follow this code change. Rather than have the Town's existing cemetery go through a conditional use process, allowing this use to be permitted seems a more appropriate choice. Cemeteries would still be allowed as a conditional use in the A, R-1, and R-1A zones. Areas currently zoned P (Public) include property owned by the Town, School District 29J, and Bennet-Watkins Fire District.

A Public Hearing was held by the Planning and Zoning Commission on April 15, 2024 and they voted in favor of the proposed code change and resolution.

Planning Commission Recommendation

Planning Commission recommends approving Ordinance 780-24 amending Chapter 16 of the Bennett Municipal Code to allow cemeteries to be a Permitted use in the P (Public) zone district.

AN ORDINANCE AMENDING CHAPTER 16 OF THE BENNETT MUNICIPAL CODE TO ADD CEMETERIES AS A PERMITTED USE IN THE PUBLIC (P) DISTRICT

WHEREAS, the Board of Trustees of the Town of Bennett previously adopted Chapter 16 of the Bennett Municipal Code, which sets forth requirements for the use and development of land within the Town; and

WHEREAS, the Board of Trustees desires to consider amending Chapter 16 to include cemeteries as a permitted use in the Public (P) District; and

WHEREAS, on April 15, 2024 the Bennett Planning and Zoning Commission held a duly-noticed public hearing on the proposed amendment and adopted Resolution No. 780-24,recommending to the Board of Trustees that cemeteries be added as a permitted use in the Public (P) District; and

WHEREAS, the Board of Trustees has considered the recommendation of the Planning and Zoning Commission and has held a duly-noticed public hearing on the proposed ordinance.

NOW, THEREFORE, BE IT ORDAINED BY THE BOARD OF TRUSTEES OF THE TOWN OF BENNETT, COLORADO:

<u>Section 1.</u> Section 16-2-470 of the Bennett Municipal Code, which sets forth the land uses that are permitted by right or as conditional uses within the Town, is hereby amended as it relates to cemeteries to read as follows (words or notations to be added are <u>underlined</u>; words or notations to be deleted are <u>stricken through</u>):

Sec. 16-2-470. Land Uses.

Section 2. If any portion of this ordinance is held to be invalid for any reason, such decision shall not affect the validity of the remaining portions of this ordinance. The Board of Trustees hereby declares that it would have passed this ordinance and each part hereof irrespective of the fact that any one part be declared invalid.

Section 3. The repeal or modification of any provision of the Municipal Code of the Town of Bennett by this ordinance shall not release, extinguish, alter, modify, or change in whole or in part any penalty, forfeiture, or liability, either civil or criminal, which shall have been incurred under such provision, and each provision shall be treated and held as still remaining in force for the purpose of sustaining any and all proper actions, suits, proceedings, and prosecutions for the enforcement of the penalty, forfeiture, or liability, as well as for the purpose of sustaining any judgment, decree, or order which can or may be rendered, entered, or made in such actions, suits, proceedings, or prosecutions.

Background


The Town of Bennett is considering vacating the Greg's Place right-of-way (ROW). The Town Engineer recommends an easement be created to allow utilities to be placed under the Greg's Place right-of-way to serve existing and future buildings in the area.

The Colorado statute that authorizes the Board to vacate a right-of-way only allows the reservation of an easement for existing utility lines and pipes, not future ones. However, the vacation of the right-of-way would be subject to any easements that were in existence prior to the vacation. Therefore, the first step is for the Town to create the needed utility easement by conveying the easement to itself. Then the second step will involve vacating the right-of-way, but by then the vacation will be subject to the Town's utility easement.

The purpose of the documents you are considering tonight is to accomplish the first step – creating the non-exclusive utility easement in the name of the Town of Bennett. This is done by adopting an ordinance approving the utility easement deed.

This matter will come back to the Board in the future once the utility easement deed has been recorded. At that time, the Board will consider the second step, which will be to vacate the Greg's Place right-of-way, subject to the utility easement.

Vicinity Map








Vicinity Map

- 1. The Grantor hereby grants, conveys, and quitclaims to the Grantee a non-exclusive utility easement, over, across and through the Property at the location depicted as "Utility Easement" on Exhibit A, attached.

- 3. The Utility Easement granted herein and the rights and obligations provided for in this Deed shall be binding upon and inure to the benefit of the Grantor and Grantee and their respective successors and assigns.
- 4. The Utility Easement shall be subject to all current restrictions and easements of record and/or apparent on the Property.
- 5. Use of the Utility Easement by a utility provider shall be subject to an agreement with the Grantee for such use and shall also be subject to all applicable federal, state and local laws and regulations.



AN ORDINANCE APPROVING A NON-EXCLUSIVE UTILITY EASEMENT DEED IN THE GREG'S PLACE RIGHT-OF-WAY

WHEREAS, the Board of Trustees of the Town of Bennett, Colorado, pursuant to Colorado statute and the Bennett Municipal Code, is vested with the authority of administering the affairs of the Town; and

WHEREAS, Colorado statute, including Section 31-15-713, C.R.S., authorize the Board of Trustees, by ordinance, to dispose of interests in real property, such as easements within the Town; and

WHEREAS, the Town is the owner of a certain right-of-way within the Town's boundaries known as Greg's Place right-of-way; and

WHEREAS, the Board of Trustees has determined that a utility easement across and through a portion of the Greg's Place right-of-way, as described and depicted on the Non-Exclusive Utility Easement Deed attached as Exhibit 1, is needed for future underground utilities; and

WHEREAS, granting the utility easement as provided in Exhibit 1 will allow access to and beneath the easement area for the installation, construction, maintenance, repair and replacement of all underground utilities.

NOW, THEREFORE, BE IT ORDAINED BY THE BOARD OF TRUSTEES OF THE TOWN OF BENNETT, COLORADO AS FOLLOWS:

The Board of Trustees hereby declares that it would have passed this Ordinance and each part or parts thereof irrespective of the fact that any one part or parts be declared unconstitutional or invalid.

<u>Section 5.</u> Repeal. Existing ordinances or parts of ordinances covering the same matters embraced in this Ordinance are hereby repealed and all ordinances or parts of ordinances inconsistent with the provisions of this Ordinance are hereby repealed except that this repeal shall not affect or prevent the prosecution or punishment of any person for any act done or committed in violation of any ordinance hereby repealed prior to the effective date of this Ordinance.

Background

The goal of the RFQ (Request for Qualifications) is to establish a roster of consultants that can provide professional services to the Town on an as-needed basis. The Town invited qualified consultants to submit proposals for on-call services in the professional services categories of architecture and design, engineering, surveying, right of way agents, ecological services, security services and geotechnical services.

The selected consultants will perform services on an as-needed basis as requested by the Town. Project costs will not exceed \$100,000 per project and task orders will include specific project requirements with a scheduled price. It is important to note that the on-call services contract does not authorize any specific work or constitute a guarantee that any work will be assigned to a contractor.

Summary of RFQ

The On-Call Professional Services RFQ was posted on Bidnet as well as the Town website on March 26, 2024 and the RFQ was due on April 15, 2024 at 10:00 a.m. The Town received 37 qualified proposals in varying professional services. All professional services outlined in the RFQ were represented in the proposals. SUBJECT: Sales Tax Oversight Committee

Background

The Town of Bennett by Resolution 594-15 established the Sales Tax Capital Improvement Fund Oversight Committee. This resolution was brought forth at the time to establish a separate committee to review the use of the sales tax increase authorized by voters in 2015 for street purposes. The resolution formed a committee to review, oversee and make recommendations to the Board regarding the use of the revenue generated by the one percent sales tax. However, there is limited rules applying to the committee, for its quorum, terms, vacancies/removals and meetings.

Per the language of the ballot question (attached), the committee was not expressly called out and is advisory in nature as the Board of Trustees makes all final decisions on the use of the sales tax.

Staff Recommendation

After discussions taking place after recent meetings, I was asked to bring the matter of the rules, regulations and need for the committee forward to the board for consideration and discussion.

In review with the Town Attorney, because the Board established the committee by resolution further action would need to be taken by the Board for subsequent actions.

Possible outcomes moving forward are to:

- 1. Review the need for the committee
- 2. Set in place further rules and procedures
- 3. Make no changes.

As a review would take place for outcomes one and two, the Town Attorney suggested a moratorium be placed via resolution in order to review the committee and terms.

Staff seeks Board direction in the matter moving forward.

1. Arapahoe County Sheriff's Report

Sgt. Todd Fechner, Arapahoe County Sheriff's Office, presented the second (2nd) quarter Report to the Board. Sgt. Fechner advised there were a total of 14 calls during the period of April 1 to June 30, 2015; of those calls only two (2) resulted in actual reports issued.

Arapahoe County Sherriff's in conjunction with other agencies will conduct an active shooter response exercise in the corridor on August 14, 2015. Strasburg and Byers High Schools will also participate in this exercise.

2. Citizen Task Force Recommendation

Paul Hanley, George K. Baum & Company, presented the results of the public opinion survey mailed to residents regarding the proposed sales tax increase for street improvement. The results were as follows:

72% support for the proposed sales tax measure is a very favorable number

- Support intensity is strong (45% definitely yes vs. 13% definitely no)
- Strong support from both homeowners and renters
- Strongest support from new residents
- Strongest support from voters 41-60 years old, followed by voters 61 and older
- Initial reaction to proposal favorable (some concerns around transparency, cost to residents, no sunset)

There is a strong level of awareness (67% a lot or some awareness).

Each argument in support that was tested resonated with participants, especially arguments focused on "wear and tear on residents' vehicles due to potholes" and the fact that "only 16% of Bennett's streets are in fair or good condition."

The only argument against the proposal that had intensity was the argument that "the Town should have been putting money aside for street improvements."

Residents who indicated concerns with the proposal mentioned a need for transparency, if the tax would sunset, revenues should be focused on streets, cost of repair and also inquired about the improvement of drainage issues, to name a few. A complete response is available on-line and in the office of the Town Clerk.

Neal Mancuso, a member of the Citizens Task Force, presented the recommendation of the Citizens Task Force to the Board.

Based on detailed information presented to the Task Force—coupled with external community opinion research—the Task Force feels it is in the Town of Bennett's best interest, as well as that of the community as a whole, to put forward a ballot question on the November 3, 2015 ballot asking for a 1-cent sales tax increase to fund street improvements. The task force felt that the data presented a compelling case to move forward with a funding proposal to address the Town's aging streets. In addition, the community opinion survey further underlines the community's support for the proposed street improvements and funding proposal, which reinforced the Task Force's final decision. The Task force also discussed and proposes that a Blue Ribbon/Transparency Committee be appointed by resolution of the Town of Bennett Board of Trustees so that the spending and monitoring of the funding source can be reviewed by an additional committee and be reported back to the Board of Trustees.

The decision in support of the sales tax increase was unanimous by those present at the final Task Force meeting on July 22, 2015.

RESOLUTION NO. 594-15

A RESOLUTION ESTABLISHING THE TOWN OF BENNETT SALES TAX CAPITAL IMPROVEMENT FUND OVERSIGHT COMMITTEE AND CONCERNING THE MEMBERSHIP, GOALS AND RESPONSIBILITIES OF SAID COMMITTEE

WHEREAS, the Board of Trustees plans to call a special election to be held November 3, 2015 and plans refer to the registered electors of the Town a TABOR ballot issue proposing a sales tax increase of one percent commencing January 1, 2016 and proposing the authorization of debt for street purposes; and

WHEREAS, the Board of Trustees desires to establish an advisory committee to review, oversee and make recommendations to the Board regarding the Town's use of the revenue generated by the one percent sales tax increase if the tax is approved by the voters; and

WHEREAS, the Board of Trustees by this resolution formally establishes the Sales Tax Capital Improvement Fund Oversight Committee as an advisory committee of the Board of Trustees and to set forth certain provisions regarding the membership, goals and responsibilities of the Committee;

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF TRUSTEES OF THE TOWN OF BENNETT, COLORADO:

<u>Section 1.</u> The Town of Bennett Sales Tax Capital Improvement Fund Oversight Committee (the "Committee") is hereby formally established by the Board of Trustees. The Committee shall be an advisory committee of the Board of Trustees. The Committee shall consist of seven members, as follows: one Trustee from the Town Board of Trustees, the Town Treasurer, and five residents of the Town. The Trustee and resident members shall be appointed at a public meeting by the Mayor, subject to approval by a majority vote of the Board of Trustees.

Section 2. The following rules shall apply to the Committee:

- A. Quorum: Four members of the Committee shall constitute a quorum. A majority of the quorum is required to act on any matter before the Committee, but in the absence of a quorum, a lesser number may adjourn any meeting to a later time and date.
- B. <u>Term:</u> The Trustee and Town Treasurer shall serve ex officio. The Trustee member of the Committee shall be appointed to a two-year term, which term shall commence on the December 1, 2014 and shall expire on the fourth Tuesday of April two years later, subject to the requirement that service shall be concurrent with his or her service as Trustee. A Trustee member of the Committee may be reappointed without any limit on the total number of terms served.
- C. <u>Vacancies/Removal:</u> A vacancy in the position of the Trustee member of Committee shall be filled by appointment at a public meeting by the Mayor, subject to approval of the Board of Trustees. The term of any person appointed to the Committee to fill a vacancy left by a vacating Committee member shall expire on the expiration date of the term of the vacating

vacating Committee member shall expire on the expiration date of the term of the vacating Committee member. The Trustee member of the Committee may be removed from the Committee for any reason by an affirmative vote of a majority of the entire Board of Trustees.

- D. <u>Meetings:</u> The Committee shall meet at least twice each calendar year unless there is no business for the Committee to consider. Regular meeting times and locations shall be determined at the first Committee meeting of each calendar year. Meetings of the Committee shall be subject to the Colorado Open Meetings Law. Staff to the Committee shall keep an accurate summary or minutes of all Committee meetings, which shall be open for inspection in accordance with the Colorado Open Records Act.
- <u>Section 3.</u> The Committee shall serve in an advisory capacity to the Board of Trustees on matters of interest to the Town and Town Board concerning the one percent sales tax increase approved in the November 3, 2015 election. The Committee's goals and responsibilities include, but are not limited to the following:
- A. Review expenditures and appropriations of the tax revenues generated as a result of the passage of the one percent sales tax increase approved in the November 3, 2015 election to ensure that expenditures have been made in accordance with the parameters set forth in the ballot issue.
- B. Review, comment, on, and provide recommendations to Board of Trustees of the Town of Bennett regarding the use of the additional one percent sales tax that voters approved in the November 3, 2015 election.
- C. Provide funding recommendations to the Board of Trustees on the use of the additional one percent sales tax that voters approved in the November 3, 2015 election each year during the budget process.
 - D. Gather information regarding the needs and priorities of street improvements.
- <u>Section 4.</u> The Committee shall have the power to adopt bylaws, rules, policies and procedures for the conduct of its activities, which shall be consistent with the provisions of the Bennett Municipal Code, resolutions and other applicable law. The Committee shall have the power to determine and appoint its own officers, to include a chair and a recording secretary, and such other officers as the Committee may determine.
- <u>Section 5.</u> This resolution shall not take effect unless and until a majority of the registered voters voting at the special municipal election on November 3, 2015 vote "yes" in response to the TABOR ballot issue proposing a one percent sales tax increase.

The Sales Tax Capital Improvement Fund Oversight Committee, a special citizen-led blue ribbon committee, will be formed to ensure that all the sales tax revenues continue to go toward roadway improvements.

Even with a 1% increase in the sales tax Bennett's sales tax rate will be lower than Aurora, Brighton, Castle Rock, Commerce City, Northglenn, Parker, Thornton, Westminster, and many other towns and cities in the area.

About 84% of Bennett's streets are in poor condition. In fact, 80 out of 94 of the Town's street segments are at least 30 years old.

With the passage of Issue 2H, our streets can be fixed within 8 to 10 months. Without additional funding, it would take decades to fix Bennett's aging streets.

A recent community opinion survey of registered voters in Bennett revealed very strong support for the 1-percent sales tax proposal, including homeowners and renters, voters of all ages, as well as both new residents and those who have lived in our community for many years.

Improving Bennett's roadways will (1) reduce wear and tear on residents' vehicles, (2) improve driver and pedestrian safety, (3) protect property values, (4) enhance emergency response capabilities, and (5) strengthen the Town's ability to attract and retain businesses with well-paying jobs.

The longer the Town of Bennett waits to address street improvements, the more it will cost. In fact, the cost to repair and reconstruct the Town's streets has increased by 39% in just the past two years.

Issue 2H is a smart proposal and is the result of our community's common-sense input.

Issue 2H deserves our support.

Summary of Written Comments Against Issue:

No comments were filed by the constitutional deadline.

The Sales Tax Capital Improvement Fund Oversight Committee, a special citizen-led blue ribbon committee, will be formed to ensure that all the sales tax revenues continue to go toward roadway improvements.

Even with a 1% increase in the sales tax Bennett's sales tax rate will be lower than Aurora, Brighton, Castle Rock, Commerce City, Northglenn, Parker, Thornton, Westminster, and many other towns and cities in the area.

About 84% of Bennett's streets are in poor condition. In fact, 80 out of 94 of the Town's street segments are at least 30 years old.

With the passage of Issue 2H, our streets can be fixed within 8 to 10 months. Without additional funding, it would take decades to fix Bennett's aging streets.

A recent community opinion survey of registered voters in Bennett revealed very strong support for the 1-percent sales tax proposal, including homeowners and renters, voters of all ages, as well as both new residents and those who have lived in our community for many years.

Improving Bennett's roadways will (1) reduce wear and tear on residents' vehicles, (2) improve driver and pedestrian safety, (3) protect property values, (4) enhance emergency response capabilities, and (5) strengthen the Town's ability to attract and retain businesses with well-paying jobs.

The longer the Town of Bennett waits to address street improvements, the more it will cost. In fact, the cost to repair and reconstruct the Town's streets has increased by 39% in just the past two years.

Issue 2H is a smart proposal and is the result of our community's common-sense input.

Issue 2H deserves our support.
